Possibly \$800 for prizes and programs plus the author visit. Jenn will ask if we can purchase signedf books through the author to see if that will take off the price.

Mini golf – We are rolling with mini golf. We still need to check the equipment to see what state it is in. The architecture firm for the library would like to sponsor a hole. The Scouts will get to sponsor a hole with labor. We will also add a cub scout time for mini golf.
